Good evening all

It is correct that the bus shelter is a condition of the planning permission. Because the council recommended refusal of the site there, were no conditions prescribed until the appeal inspector added them to his decision to allow permission (I think that's the process). Later, in 2023, the developer applied for an amendment to the bus shelter condition under s. 73. This was just to allow them to complete the provision of the bus shelter prior to first occupation rather than prior to commencement of work. The wording is otherwise the same as the original condition. The amendment was approved by the planning department.

The condition now reads:

'Prior to the occupation of the development hereby permitted, additional bus stops shall be provided along Station Road adjacent to the development's footway. The stops shall be provided with real-time information screens, easy access kerbs and appropriate shelters. Such works shall be secured through the implementation of a S278 Agreement with the Local Highway Authority.'

The planning manager said that the conditions should be adhered to (shelter, information screens) but I have now asked if they will question the design of the bus shelter as proposed by Highways on the grounds of its incongruous modern appearance. The specification of "appropriate shelters" would seem to be an important factor here. I'll let you know what they say.

Meanwhile, the resident at no. xxx says the contractor agreed in a meeting this morning to delay commencement of the work until more was known about all of this.

Good morning Graham,

I'm sure you are now being made aware of the concerns of local residents about the plans to erect a modern bus shelter complete with a digital information board outside 101 Station Road. As a resident opposite this location we are very unhappy about such a structure. It seems to us to be incongruous and not in keeping with a rural setting and will have potential consequences for visibility and traffic congestion along this(at times) very busy road.

We have not been aware until yesterday, of the plans for such a shelter and feel it is wholly unnecessary especially as very few people use the bus service from this road. Whilst we are fully supportive of public transport we feel we have not been consulted about the positioning of a new bus stop or indeed a bus shelter.

This section of Station Road is a key parking area particularly at the weekend when there is football training or matches at Small Gains. This is likely to lead to more parking and congestion further down Station Road.

This morning a number of residents have spoken with a person from the developers who has agreed to conveys our concerns to his supervisors.

We are hoping the PC will support us in raising these objections with those in authority.
